Location Benefits

- Located 19 miles west of I-95, along 4-lane Georgia 119, just off 4-lane U.S. 84, a major trucking corridor between the East Coast and the Florida panhandle
- 37 miles to I-16, 40 miles to Savannah-Hilton Head International Airport, and 45 miles to Port of Savannah
- 115 miles to Jacksonville, FL

- Savannah Technical College has a modern satellite campus in Hinesville TP with classrooms, computer labs, and other instructional facilities that will also include a proposed Precision Manufacturing Center with industrial systems, machine tool, robotics and welding/joining instruction; as well as a truck driving course.
